## AUCTORIUM – ABOUT THE AUTHOR



**Alexander J. Bělohlávek**

**Prof., Prof. zw., Dr. et Mgr., Dipl. Ing. (oec), prof. hon., dr. h. c.**

Professor Bělohlávek studied at the Law Faculty of Jan Evangelista Purkyně University in Brno [presently known as Masaryk University], and graduated from the Faculty of Law of Charles University in Prague. The Author earned his first degree (Civil Law I.) at the Law Faculty at Charles University in Prague in December 1993. From 1991 to 1996, the Author lectured at the Faculty of Law of Charles University in Prague, the Institute of Copyright, Industrial Property Rights and Competition Law, and subsequently at the Department of Commercial and Economic Law – Private International Law Division. He has been a member of the Department of Law, Faculty of Economics, VŠB – Technical University of Ostrava, since 1992. The Author is a member of the department council for postgraduate doctoral studies at the Faculty of Economics, VŠB – Technical University in Ostrava (CZ), and at the Faculty of Law of Masaryk University in Brno. He was awarded the title of associate professor (*docent*) in 1996. On 1 April 2001, the Author was pronounced full *professor*.

He has been a commercial lawyer since 1993, and in 1994 was admitted to the bar in Prague, with a licensed branch of his law firm in the U.S. (New Jersey). In 2002, the Author was also awarded the honorary title of *doctor honoris causa* at the Kyiv University in Ukraine, Faculty of Law and Economics, and in 2015 the honorary title of *profesor honorificus*.

Apart from his legal practice and lecturing, the Author has held many offices and has become member of several major foreign institutions, associations and commissions. From 2011 to 2015, the Author held the office of President of the WJA – *The World Jurist Association* (Washington, D.C., U.S.), and has been a member of the WJA Board of Governors ever since.

The Author is Vice-President of the International Arbitration Court at the Czech Commodity Exchange, arbitrator at the Arbitration Court at the Economic Chamber

of the Czech Republic and Agricultural Chamber of the Czech Republic, Vienna International Arbitral Centre (VIAC) at the Austrian Federal Economic Chamber, International Commercial Arbitration Court at the Chamber of Commerce and Industry of the Russian Federation, International Arbitration Court at the Belarusian Chamber of Commerce and Industry, and International Commercial Arbitration Court at the Ukrainian Chamber of Commerce and Industry in Kiev. He also serves as arbitrator at arbitral tribunals (arbitration courts) in Almaty (Kazakhstan), Chisinau (Moldova), Vilnius (Lithuania), Bucharest (Romania), Sofia (Bulgaria), Ljubljana (Slovenia), Zagreb (Croatia), Kuala Lumpur (Malaysia), Harbin (China), Shenzhen (China), et al. The Author also resolves disputes that fall within the jurisdiction of the ICC (International Chamber of Commerce), International Court of Arbitration in Paris, and according to UNCITRAL Rules. He is also entered on the list of arbitrators for resolving disputes according to selected international trade agreements entered into by the EU and third countries. The Author was a member of the ICC International Court of Arbitration in Paris from 2009 to 2018, and held the office of Chairman of the Commission on Arbitration at the National Committee of the ICC in the Czech Republic from 2005 to 2017. He is also a member of the Swiss Arbitration Association (ASA), Austrian Arbitration Association (ArbAut), German Institution of Arbitration (DIS), International Chamber of Commerce (ICC), American Society of International Law (ASIL), Associated Member of the Law Society of England and Wales, member of the International Law Association (ILA, Headquarters branch, London), International Bar Association (IBA), and other international organizations.

Prof. Bělohlávek has also authored or co-authored more than 120 monographs (in Czech, German, English, Russian, Ukrainian, Polish, Spanish and Romanian), more than 320 academic articles, especially in the field of private international law, procedural law, commercial and financial law, as well as certain topics from public international law and international finance. In the Czech Republic, the Author is a member of the editorial board of *Bulletin advokacie [Advocacy Bulletin]* published by the Czech Bar Association in Prague, *The Lawyer Quarterly* published by the Institute of State and Law of the Academy of Sciences of the Czech Republic (AV ČR, v.v.i.), and other periodicals in the Czech Republic and abroad.
